The TRUTH is that when you have only seconds to save your own life or that of a family member, the Police are only minutes away! Can you dial 911 while trying to protect yourself or a family member?

You are the only one responsible for your survival. You are only going to see the Police <u>after</u> the Critical Encounter with a criminal is over, that is, <u>if</u> you survive it.

Of course, avoidance is always the best way to prevent an encounter with a criminal. But what can do you do when avoiding the situation is not possible?

Do you have any kind of a plan in case the worst happens? Does your spouse or partner know what to do in the event of an unavoidable encounter?

Ninety-five percent of people do not have a plan...and many people become victims!

How do you avoid a potential encounter with a criminal? What can you do to better prepare yourself to survive one?

The first step is to start being *aware* of your surroundings... all of the time...when you're at the Mall, or even when you're at home. You have to be aware of what is happening around you.

If you see a situation developing, you may be able to avoid it, or at least be prepared to react to it if necessary.

Learn as many self-defense skills as you can, in case avoidance is not an option.

Do as much as you can do to *burglar-proof* you home. Put dead-bolts on your bedroom door so you have a place you can go that would give you some extra time to arm yourself and dial 911.

When you're away from home, stay very observant of your surroundings. If you're in an area where there are not several other people, try not to let any unknown individuals close enough to do you harm. You can be Aware, Alert, & Cautious without being paranoid. *HAVE A PLAN!*







EQUIPMENT CHECKLIST

There may be some debate by some people about exactly what ammunition and what equipment you should have. We are going to give you a good starting point, with the needed information, for you to develop your own personal every day "Survival Kit". A few well chosen tools can mean survival. Now we realize that you are probably not going out in the woods and get lost or something to that effect. We also realize, however, that each day you should have with you the needed tools to survive a Critical Encounter. That encounter may be with a criminal, or it may be trying to get out of a burning building when the lights have gone out.

Take a look at the checklist below to get an idea of a good "basic" everyday survival kit. These tools will help you survive most situations you might encounter, that is, if you have your tools with you!

For most life-threatening encounters:

- >> Your Firearm* loaded with a major manufacturer's hollowpoint, Personal Protection ammunition, that you have already tested and that functions properly in your firearm.
- >> You may also want to have a Less Lethal* alternative such as pepper spray, stungun, or expandable baton.
- >> Other items which could prove invaluable are a small, good quality, dependable flashlight, with a bright (90 lumens or more) beam, as well as a small, good quality knife, either folding or straight bladed. A loud whistle could also be a life saver in the event of hurricane, tornado, or earthquake.
- * Check your own State's laws regarding carrying any of these weapons on your person. In some states, it's a felony! >> A cell phone (even if you don't have a contract, most cell phones will still allow 911 calls).
- >> Be Aware, Alert, Cautious, and HAVE A PLAN!
